Key definitions

- Domiciliary/home care – Paid carers visit a person’s home and provide help with personal care tasks such as washing and dressing, daily living tasks such as meal preparation, reminders to take medication, etc. The hourly rate charged for services depends on what is required, the time of day and location.
- Live-in care – If people require a lot of help with their personal care, it may be easier to have a support worker/paid carer who lives in their home. This can be on a permanent basis or short-term following an illness or stay in hospital. Charges for live-in care depend on the amount of care and the skills and support required.
- Residential care – Residential care homes are for people who can’t continue to live at home, even with additional support or changes to their home. A residential care home helps people with personal care, including eating, washing, going to the toilet, and dressing. These homes do not offer nursing support.
- Nursing care – Nursing homes provide the same personal care as residential care homes, but also they provide 24-hour nursing care by trained nursing staff. If the person requiring care has a diagnosis of dementia, then their family/carers will need to make sure that the home is registered to meet these needs.
- Respite care stay – A short-term stay in a residential care home for a cared-for person to give a person who cares for them a break from caring responsibilities.
- Reablement – This is a short-term service designed to help people to become as independent as possible following an illness, an operation or a long-term condition, through learning or re-learning the skills necessary for daily living.
